






## BUYER ADDED ADDITIONAL TERMS AND CONDITION

- 1- Tenderers are advised to study the tender document carefully and thoroughly. Submission of Proposal shall be deemed to have been done after careful study and examination of the tender document with full understanding of its implications.
- 2- All information about e-tender with Tender documents are also be available on website of MP Homeguard ([www.homeguard.mp.gov.in](http://www.homeguard.mp.gov.in))
- 3- One bidder cannot submit two different Make/Model for same item in the bid.
- 4- A minimum specification has been specified in the RFP. Bidder can propose items of better/higher specifications.
- 5- If the supplier firm does not supply the material within stipulated period and has not been granted/permitted for extension of delivery period then EMD will be forfeited and purchase order would also be cancelled. For a certain period, the firm will be blacklisted with the approval of competent authority. This notice will be sent to concerned corporation/organization/board/firm and the department will ensure that no purchase order will be placed to that firm for M.P. Homeguard/sderf.
